All bids in one original plus three copies, properly filled in, and enclosed in plain envelopes must be delivered to the address below at or before 4.5.2018 Bids will be opened promptly thereafter in public and in the presence of Bidders' representatives who choose to attend in the opening at the Mbeya District Council Office.
